Using our methodology, FTM national reports provide evidence which can be used to identify the main bottlenecks in national tax systems and recommend solutions, stimulating debates and enabling civil society to push for policy changes.

OUR IMPACT

The FTM project funds, supports, and facilitates research and advocacy for fair taxation. FTM projects enhance partner organizations' knowledge, capability, credibility, and confidence to engage with public and private stakeholders on fiscal policies and practices.

CAPACITY BUILDING

Based on mutual learning and technical assistance, FTM programs have increased partners' fiscal knowledge and their capacity to engage with policy makers on fair taxation. In a survey conducted with FTM partners in 2023, 17 out of 20 respondents affirmed that working with the FTM had improved their ability and confidence to discuss fair taxation with other organizations and government bodies.

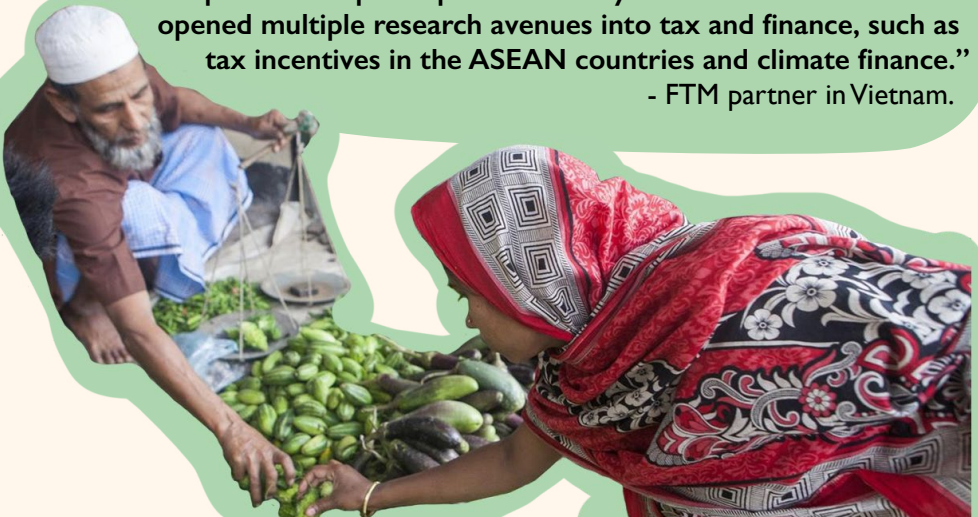

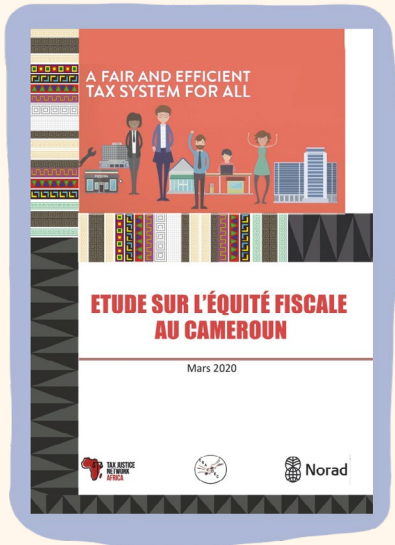
